1. In its drive to increase access to ICT services, especially in the rural areas, MACRA through the Universal Service Fund (USF) identified resources to cater for the construction of purpose-built Model ICT Laboratories under the Connect a School Project.
2. MACRA therefore intends to use part of the funds to procure Building Materials for the construction of up to 120 ICT laboratories under the **Second Phase** of the project across the country.
3. **The Chairperson, Internal Procurement and Disposal Committee (IPDC)**, now invites sealed bids from eligible Suppliers for the following categories of goods and services;
