1. The Malawi Communications Regulatory Authority (MACRA) set aside funds to be used for the **Provision of Electrical Repair and Maintenance Service**.
2. **The Chairperson, Internal Procurement and Disposing Committee (IPDC)**, now invites sealed bids from eligible bidders for the Provision of Electrical Repair and maintenance service.
3. Bidding shall be administered in accordance with the National Competitive Bidding (NCB) procedures as specified in the Public Procurement and Disposal of Public Assets Act, 2017 and its subsidiary legislation.
4. Interested eligible bidders may obtain further information and inspect bidding documents from MACRA's Procurement Department at the address given in paragraph 7(i) below from **08:00 – 12:00 Hours, 13:00 to 16:00 Hours** local time (Monday to Friday) except national public holidays
5. A complete set of Bidding Documents in English language may be obtained by interested bidders at 7(ii) upon payment of a non-refundable fee of **MK5,000.00**. The

method of payment shall be cash or Bank Certified cheque. The documents may be obtained in person by the prospective bidders.

6. Sealed bids must be submitted to the address at 7(iii) below at or before **15:00 hours** on **Thursday 11th November 2021**. Late bids shall be rejected and returned to the bidder unopened.
